#### **2024 Stevens Fellows**

With the support of former clerks to Justice Stevens and other generous donors, in 2024 the John Paul Stevens Foundation supported 157 Stevens Fellows selected by 38 law schools and 3 nonprofits working on substantive issues that were of great importance to Justice Stevens.

During their summers, the 2024 Stevens Fellows worked at more than 136 different public interest agencies in 23 different states, collectively doing over 50.000 hours of public interest legal work.

This summer the Foundation also celebrated the <u>selection of the 1,000th Stevens Fellow</u>, a milestone moment in the program's 27-year history. There are now <u>over 1,100 alumni</u> of the Stevens Fellowship, and 73% of the Fellows who have graduated from law school are working in public interest careers.



## **2024 STEVENS FELLOWS - AN OVERVIEW**

The 157 Stevens Fellows in 2024 were selected by 38 law schools and 3 nonprofits across the country. The Stevens Fellows came from a wide variety of backgrounds and experiences. Of the Fellows, 54% identify as being BIPOC (Black Indigenous, and People of Color), 62% identify as female, 32% identify as LGBTQIA+, and 52% identify as first-generation attendees of professional or graduate school.



## **Public Interest Employment**

The 2024 Fellows worked at 136 unique public interest agencies across 23 jurisdictions. Approximately 45% of the Fellows worked at public interest nonprofits, 28% worked in federal, state, or local public defense, and 27% worked at other government agencies.
